**U.S. EXHIBITORS** – Payment should be made out for the full entry amount in Canadian Funds. Bank drafts or money orders payable in Canadian funds are probably the best choice.

**BITCHES IN SEASON** – will be allowed to compete, but will be judged last or in such a way so as not to disturb other dogs. Please notify the trial secretary as soon as possible prior to the test.

**ALTERNATE LIST** – Any entries remaining will be placed onto the Alternate List as determined by a random draw. Entries from the Alternate List may fill any absentee spaces at the time of the draw for tracks. The person making the entry shall be notified of their position on the Alternate List. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

**ROSETTES** – A qualifying rosette will be awarded to each dog successfully completing the Tracking Test.
