**Entry Fees: \$150.00 for Open and Amateur Stakes** and **\$50.00 for Puppy Stake** and listing fees for dogs not registered with the C.K.C. is **\$10.50** per day unless an ERN has been applied for. *No dog will be allowed to compete unless fees have been paid.*

**TCN Fee:** A TCN fee as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form. All owners of unregistered, CKC-recognized breeds entering events are required to obtain a Temporary Competition Number (TCN).

**Event Registration Number:** All dogs that are foreign born and foreign owned require an event registration number (ERN) to enable them to be awarded titles by the CKC. Dogs may be entered as "listed"; however, an ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. Application forms may be obtained from the Field Trial Secretary.

**Non-Member Participation Fee:** An annual fee for awards and titles will be charged to a Canadian nonmember of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled. NOTE: it is less expensive to become a CKC member than to pay this fee each year.

**Puppy Stake:** “A Puppy Stake at a Spaniel Field Trial shall be for dogs at least 6 months of age and under 2 years of age on the day of the trial at which the Puppy Stake is judged.” *CKC sporting Field trial Rules and Regulations Chapter 10, section 2.*

**Limit Stake:** “A Limit Stake at a Field Trial shall be for dogs that have not placed in an Open All-Age Stake or received 2 first placement in any Regular Official Stake (Puppy Stake excepted), at an approved trial in Canada or equivalent Spaniel trial in any other country. *CKC sporting Field trial Rules and Regulations Chapter 10, section 3.*

**Open All-Age Stake:** “An Open All-Age Stake Field Trial shall be all dogs at least 6 months of age on the day of the trial at which the stake is judged. *CKC sporting Field trial Rules and Regulations Chapter 10, section 4.*

**Amateur All-Age Stake:** “An Amateur All-Age Stake Field Trial shall be all dogs at least 6 months of age on the day of the trial at which the stake is judged.” A person shall be considered an amateur if he has not attempted to receive any part of his livelihood from training, handling, or showing of field trial or hunting dogs in the calendar year of the trial or the preceding calendar year. Dogs running an Amateur Stake must be owned by an amateur and handled by an amateur.” *CKC sporting Field trial Rules and Regulations Chapter 10, section 6.*

**Points:** Championship Points are awarded for placements in the All-Age Stakes, provided that there are 10 or more starters:

1<sup>st</sup> Place = 5 Points, 2<sup>nd</sup> Place =3 Points, 3<sup>rd</sup> Place =2 Points, 4<sup>th</sup> =1 Point.

**Indignities:** “It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.” *CKC Sporting Spaniel Field Trial Rules and Regulations, Chapter 21, section 7.*

*Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted.*

*Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.*

*Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks.*

*To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds.*

## **Notes:**

Puppy stakes will be held August 25<sup>th</sup> and 26<sup>th</sup> between the 2<sup>nd</sup> and 3<sup>rd</sup> series of the Open All-Age stakes each day.

## **Lunch and refreshments will be available**

***Gallery (Spectators) & Competitors*** accordance with *The Spaniel Field Trial Rules and Regulations* an article of **BLAZE ORANGE** clearly visible above the waist, must be worn by all persons in the field. **NO** exceptions.

For a close-up view of the event we suggest that you follow along behind the Marshall in the "Gallery". If you choose to do so, please obey the instructions of the Field Trial Marshall at all times.

## **Marshall's instructions**

Follow the Marshall's instructions and keep close behind the Marshall and do not string out in a long line or spread out overly far from the center line. If the gallery has advanced down the field, spectators must not travel down or across the field to catch up—rejoin at the start of the course.

Avoid loud talk, applauding or noise while the dogs are working, as it could disturb birds or dogs.

**Children are welcome, but please keep them within the gallery at all times.**

Noncompeting dogs must not be on the grounds (except in the parking area) and should be leashed when not kenneled.

Consumption of alcoholic beverages is not permitted on the field trial grounds.

**PLEASE NO SMOKING ANYWHERE ON THE GROUNDS.**

**Overnight camping is permitted and welcomed at the Stewart Farm, please no open fires. There are no hookups.**
