No post dated cheques accepted. A post dated cheque is one that is dated after the receipt of the entry. All NSF cheques will be Subject to a charge of \$45.00. N.S.F. cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show.



Important Note Regarding Emails & Faxes - it will be the responsibility of the exhibitor to ensure that any electronic submission, either email, facsimile, or any document transmitted electronically. reaches the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules & regulations. Sent fax receipts, and/or, copies of sent emails will not be taken as evidence of receipt by recipients.

Attention USA exhibitors: Please note that fees are due and pavable in Canadian dollars. Due to consistently fluctuating

currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Pavable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.

**OBEDIENCE/RALLY O TRIAL – MOVE UP** A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title, in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules, may be moved to the next level of Obedience/RALLY O competition providing the transfer was submitted to the Trial secretary, IN WRITING by the owner or handler, one hour prior to the opening of the first trial, trial schedule permitting.

A Bitch in season may not compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary BEFORE commencement of the trial receives a Veterinarian's Certificate.

#### CATALOGUE

Catalogues will be available from trial secretary <u>on a pre-order basis only</u> - \$ 3.00. Catalogues will not be mailed to absent exhibitors.

#### **TROPHY & PRIZE LIST**

Appropriate prizes and Rosettes will be awarded for High in Class qualifying scores for all classes being offered. Rosettes will be awarded to dogs placing 2nd, 3rd and 4th in all classes being offered.

#### GENERAL INFORMATION

- The Trial Superintendent will be in full charge of the show.
- Children, accompanied by an adult, are welcome at our Trial, however please do not allow them to disturb dogs without permission of owner.
- All exhibitors will be held responsible for clean up on the trial premises and surrounding areas for their own dogs or dogs they are handling and must use the designated areas.
- It is the responsibility of the exhibitor to have their dog at ringside when it is scheduled.
- The MGRC and Stay N Play will not be held responsible for any equipment left on the grounds overnight.
- The MGRC and the Trial Committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume and liability in the event of an accident, or other misfortune to either the dogs or exhibitors or patrons. If, because of riot or civil disturbance or any other acts beyond the control of the MGRC and their Trial Committee, it is impossible to open or close the shows, no refund of entries will be made.
- Only dogs entered in the Trials will be permitted on the trial premises.
- A copy of the Rules pertaining to Dog Obedience Trials are available from the Canadian Kennel Club. Each exhibitor is responsible for knowing and complying with the rules of the Canadian Kennel Club regarding their events.
