## DIRECTIONS TO SHOW fire signs 6926 or 6924

**From the East:** Take Hwy. 401 to Hwy 6 North (exit 295). Turn left at the 1<sup>st</sup> set of lights (Wellington Rd. 34). At County Rd. 35, turn left. After crossing the 401, turn left at the first road (Concession 2) – there is a sign for Paddock Corners. Turn left at the first driveway..

**From the West:** Take Hwy 401 to Townline Rd. (exit 286). Turn right at the lights off the 401, then left at the next set of lights (Lake Rd.). Follow this road until you come to a stop sign (small lake on your right). Keep right at the stop sign, and the road turns into Concession 2. After the stop sign for Count Rd. 35, turn left into the first driveway.

**From the North:** Take the Hanlon Expressway (Hwy. 6) south to Downey Rd. (YMCA on the corner). Turn right and follow this road. After crossing the 401, turn left at the first road (Concession 2) - there is a sign for Paddock Corners. Turn left at the first driveway.

**From the South:** Take Hwy. 6 towards Guelph. After the highway goes from 4 lanes to 2, you will go over a railroad bridge. Look for the sign for Leslie Rd. and turn left (if you get to the little town of Morriston, you've gone too far). Follow Lelise Rd. to Sideroad 20 and turn right. Sideroad 20 dead ends at Concession 2. Turn left. It is the 5<sup>th</sup> or 6<sup>th</sup> property on the left. If you get to County Rd. 35, you've gone too far.
