**U.S. exhibitors**: Our bank will not accept cheques marked "payable in Canadian funds". Entry fees must be paid in Canadian Funds.

**TCN Number**: (Previously Listing fees)A Temporary Competition Number (TCN) has been established by The Canadian Kennel Club and MUST ACCOMPANY the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form. This fee is \$10.50 (incl GST) per dog per each event entered during the field test and is in addition to the entry fee(s). Exhibitors should be aware that the CKC does not confer a title on any dog until it is registered individually in their records.

It is the exhibitor's responsibility to confirm that The Secretary has received their entries.

NOTE: In the case of electronic or telephone entries, the entry is not considered complete until fee is paid and a signed entry form is received by the Test Secretary.

All entry forms must be in the hands of the Field Test Secretary BY THE CLOSING DATE and entry fees paid in full. There will be no exceptions.

While we will have a PayPal service set up for this event, it is highly recommended you use Dogshow.ca. Please take advantage of this service. Please go to <u>www.gspalberta.com</u> for PayPal entries.

**Entries close 7:00 P.M., Tuesday, June 20<sup>nd</sup> , 2023.** Running order will be posted no later than Friday June 23rd. If you do not have an email address, please call the test secretary to obtain a schedule of running order.

All entries for the Field Test are accepted on condition that the GSPFCA, its officials and members, and the land owners

(Spruce Creek Upland Club.) and horse owners, are released from all liabilities for loss, damage or injury sustained by dog, horse or person in conjunction with, or during the running of, this field test. All minors shall be under the direct care and supervision of a parent or guardian.

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Test Committee shall have the authority to take such action as it deems fit on receipt of a report indicating this has occurred.

#### **TEST INFORMATION:**

- **Courses & Birds** Partridge, Quail and/or pheasant will be released. The tests will be over a single course with birds released along the course. There will not be a bird field. Three birds will be released for the first dog tested and two birds per dog thereafter. In FDX 5 birds will be released for the first brace and two birds per dog after that. The GSPFCA reserves the right in case of a bird shortage, to use alternate bird species.
- Water Dog Events- Entries in water dog will be run concurrently with the Field test. Dogs entered in WDJ may be asked to run as they are available. Please be prepared to go.
- Horses on the course Bird planters, marshals and judges may use horses. All other participants must be on foot. All dogs will be handled on foot
- All persons on the course in FD, FDA and FDX must wear a blaze orange outer garment. A hat alone will not be allowed. If you do not have one, one will be provided.
- Gallery: Due to our desire to run as safe an event as possible galleries should be kept to a minimum and MUST stay

together in a group. Everyone in the gallery MUST have Blaze orange.

- Total entries will be limited to the **number of dogs** that can be run in approximately 8 hours of judging time. Entries will close and a waiting list will be started once this limit is reached
- Starting times will be announced. (Earliest start will be 8 am.) Running times are an estimate only and may change due to absentees or dogs "picked up" early. It is the handler's responsibility to be at the start of the course when it is their turn to run.
- FDJ & FD dogs will have 20-30 minutes to complete all aspects of the test. FDA dogs will have 30-40 minutes. FDX dogs will have 30-45 minutes. Dogs will be run individually in the FDJ & FD Tests; FDA and FDX dogs will be run in braces.
- Firearms Official gunners will be the only persons permitted to carry firearms on the test site. In FD, FDA & FDX, shotguns will be fired over dogs with bird work when possible. Shooting will be done by official gunners only. In FDJ blank shells will be fired please provide your own starting pistol.
- Bitches **in season** will be permitted to run in FDJ on both days and in the final braces on course 1 afternoon only. Please notify the secretary or test chair if you have a bitch in season.
- **Collaring** a dog is allowed with the permission of the judge.
- Tracking collars: Tracking collars will be permitted. Only tracking collars that meet the CKC guidelines will be allowed. A dog that is located using a tracking collar during its heat is no longer under judgement.
- Training or exercising of dogs is prohibited on the test grounds during the test weekend (from Friday evening until completion of judging on Sunday). Any permission to train outside of these times is at the discretion of the Spruce Creek Upland Club
- **Smoking** is prohibited except in the designated camping or headquarters area.
- Accommodation: There is no camping on the grounds permitted. There are various campgrounds in the area and hotel accommodation in Olds, Three Hills Trochu and Red Deer. <u>www.kneehillcounty.com</u> for campsite availability.
- NO OPEN FIRES WILL BE ALLOWED, PERIOD
- Food: There will be no food or beverages available for participants. Please bring your own
- Prizes Rosettes will be awarded to all qualifying dogs. All ribbons are to be claimed at the Test no ribbons will be mailed
- All participants must be familiar with CKC Rules and Regulations and also the rules, conditions and provisions of this Premium List. CKC Field Test Rules are available from the CKC. **NOTE: Make sure you review the rules for Field Dog Tests (available on the CKC website: www.ckc.ca)**

Things to remember:

1. There will be no hospitality or concession food available. Food will be supplied for all judges and workers.

2. Bring water and food for yourself and your dogs.

3. The Club is grateful to have the use of these grounds. We ask for your co-operation in keeping the grounds free of litter by using the garbage bags provided.
