## ENTRY PROTOCOL Limited Entry May 8 + 9, 2021

We will be accepting mailed in (or courier), drop off and ONLINE entries only – no faxed nor emailed entries.

- Couriered entries are NOT to have a signature required upon delivery.
- There will be approximately 25 online entries per trial available.
- For those who do not have access to online entries via DogShow.ca, we will be accepting no more than 10 entries via mail-in or courier or drop-off. Please note: all of these entries MUST be paid via cheque or credit card – no e-transfers or debit cards will be accepted.
- Entries will not be accepted prior to the posting of the Premium List. Any entries received prior to the posting of the Premium List will be returned via Canada Post.
- Entries will not be accepted that are not on the Official HCKOC Entry Forms provided with the May 2021 Premium List.
- All entries must be filled out in its entirety and with no errors or omissions.
- Envelopes of entries received will be numbered and marked in the order and date of receipt.
- Entries with errors or omissions will NOT be processed and will be mailed back to the sender via Canada Post.
- Entries received that exceed the limit of 10 will be mailed back to the sender.
- All entries, once processed, result in an email from DogShow.ca being sent to the sender notifying them of a pending approval entry. This is how you will know that your entry was received on time, was among the allowed 10 available mail-in/drop off entries and was complete and correct. Please do not contact the Show Secretary prior to this time so as to allow her to complete the entry processing.
- Should less than 10 entries be processed as a result of the mailed-in/dropped off/couriered method of submitting entries, the balance available for total entries will be made available for entry online at DogShow.ca.

A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or interac for payment.

*U.S. Exhibitors:* Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par" as they will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

### **FEES / CHEQUES / N.S.F. CHEQUES:**

All fees must accompany your entries. No entries will be accepted without accompanying full payment. Tendering of an N.S.F. cheque or credit cards that have maxed out shall be considered an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$50.00 fee charged for any N.S.F. funds issued to the Prince Albert Kennel & Obedience Club. (Post-dated cheques will NOT be accepted). Overpayment of entry fees will not be refunded.

### **OFFICIAL CKC ENTRY FORMS**

ENTRIES MUST BE TYPED OR DISTINCTLY PRINTED. Owners are responsible for errors on entries. Incomplete entry forms must be returned to the designated owner or his authorized agent. Unsigned, telephone, or telegraph entries cannot be accepted, except in the event of a postal strike when telephone entries may be made in accordance with the Canadian Kennel Club Regulations.

The following **CKC OBEDIENCE** classes will be offered:

Pre-Novice; Novice A; Novice B; Novice C; Novice Intermediate; Open A(H); Open A(18); Open B(H); Open B(18)  
Utility A; Utility B

Refund of entry fee is allowed for bitches in season provided a signed certificate is provided from a veterinarian

### **CHAPTER 20**

◆ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in the premium list and catalogue.

## GENERAL INFORMATION

1. As per CKC rules all dogs on the show premises ***MUST be listed in the show catalogue***. Any dogs not listed will be asked to leave. There will be no "IN TRANSIT" area provided.
2. There will be no overnight kennelling in the building.
3. Only approved CKC collars will be allowed in the precincts of the trials.
4. DOGS MUST BE EXERCISED IN THE **DESIGNATED AREAS ONLY**. NON-COMPLIANCE WILL RESULT IN IMMEDIATE EXPULSION FROM THE SHOW.
5. Entries will be acknowledged after entry by DogShow.ca and a judging schedule will be available after the closing date. If such acknowledgement is not received one week before the show date, please contact the Event Secretary
6. Entry fees will not be refunded for cancellation of entries if the dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee, or because it has been entered incorrectly.
7. If because of riot, civil disturbance or acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made.
8. Showing correct information on the entry form is the responsibility of the entrant. The HCKOC takes no responsibility for the omissions or errors made on the entry forms. The Trial Committee reserves the right to refuse any entry subject to the CKC rules.
9. BITCHES IN SEASON: Obedience entry fees will be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) provided a dated veterinarian's certificate is produced prior to the trial.
10. The precincts of these trials shall be the Prairieland Exhibition Hall A building and grounds.
11. The HCKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
12. All dogs must be under complete control at ALL times.
13. The selling of merchandise at these trials by other than our authorized vendors is not permitted. Anyone doing so will be expelled from the show/venue.
14. Any show official, volunteer, employee or exhibitor shall not be subjected to any indignity by anyone at these shows. Should this occur the offender may be excused from the show/building by the Show Superintendent or his/her representative.

## WAIT / RESERVE LIST

HCKOC will be accepting entries for a "Wait" or "Reserve" list.

If you wish to be put on such a list, please email a fully (and correctly) completed entry form to the Show Secretary by April 15, 2021. All entries must have credit card information included. Entries received will be sorted by date received AND CLASS. Any entries that are incomplete or incorrect will not be processed and the next submitted entry for that class will be chosen. Competitors will be notified that their entry was incomplete/incorrect and what the issue was.

CKC allows the Club to substitute an entry from the Wait/Reserve List for any dog that is withdrawn for reason of it being a bitch in season (in writing and with veterinary verification) for up to 72 hours before the start of the trial. Entry fees for the withdrawn bitch will be refunded.

CKC also allows the Club to choose to accept withdrawals (in writing) for any dog other than a bitch in season up to 72 hours prior to the Trial and substitute a dog from the same class from the Wait/Reserve List. Entry fees for withdrawn dogs will NOT be refunded.

Should your dog be substituted into a class for a dog that has been withdrawn, competitors will be notified that this has occurred. Their entry will be processed and their credit card will be charged for the applicable entry fee(s).

## **BENCHING**

There will be NO BENCHING allowed.  
There will be temporary benching spots for dogs/crates during class which are to be vacated after your class is completed in order to make space for exhibitors in the following classes.

## **COVID-19 REFUND POLICY**

If our Show is unable to proceed as planned, then the Hub City Kennel & Obedience Club will pay any Trial related expenses we are unable to recoup, then disperse the balance evenly between the entries. We are very aware of everyone's financial constraints and the HCKOC Trial Committee will continue to work diligently to mitigate any potential financial loss.

## **COVID-19 PROTOCOLS**

Province of Saskatchewan Health Authority (SHA) COVID-19 regulations will be followed.  
COVID-19 Related changes and temporary rule changes are detailed below.

- ALL competitors will be required to sign a waiver form and must turn waiver in at venue upon arrival, before competing. The Waiver is available on DogShow.ca.
- Masks are mandatory in all areas of the trial precinct – face shields alone are NOT sufficient.
- *There will be no spectators allowed at the rings.*
- There will be no food services provided on-site at the Trial
- There will be no dogs allowed as Exhibition Only or In Transit
- \*Catalogues will be provided by Email only
- There will be no public catalogue provided, so please be prepared with all of the entry information of your dog should you need to move up or change your entry.

### **COVID-19 CKC OBEDIENCE TRIAL ALLOWABLE CHANGES**

- Handler will place their leash, dumbbells etc. in a designated spot and pick up after their run. The ring steward will NOT bring your leash to you. Your dog must leave the ring on-leash and under control.
- Utility handlers please bring tongs as you may be required to handle your own articles. Stewards will wear new disposable gloves if handling scent articles and bag.
- Qualifying Rosettes, ribbons and score sheets will be left on a table for handlers to pick up if they wish at end of their class. No ribbon/rosette presentations in the ring.
- Special prizes will be verified by Trial Chair or Event Secretary and will be placed out at time of award in specified location.
- Pylons will be used for Figure 8 posts at all levels
- Group Stays – dogs will be placed a minimum of 8 feet apart for all levels. A dog that fails to qualify in the Individual Exercises will not be eligible to compete in the Group Exercise.
- NOTE – Jump Heights for dogs will be according to their correct height at the withers or for accepted veteran heights. There will be no reduced heights incorporated into these trials.
- Large classes may be broken up into groups and you will be invited in as others leave to accommodate the Group Exercises.

### **COVID-19 INFORMATION – SUBJECT TO CHANGE**

All Saskatchewan Health Authority (SHA) regulations will be followed.

- If you are exhibiting ANY symptoms of COVID-19, please do not attend the trials.
- Any handler unable to attend these trials due to exhibiting COVID-19 symptoms after entries close will receive a credit to any future CKC event hosted by Hub City Kennel and Obedience Club. Credits will expire after one year.
- MASKS will be mandatory at time of Premium List for all competitors on the precincts of the trial.
- New restrictions may be applied at time of event according to SHA regulations.
- ONLY handlers entered in the specific class being judged will be allowed into the building and we ask that you space yourselves at least 10 feet apart.
- There will be temporary benching spots for dogs/crates during class and vacated after class to make space for exhibitors in following classes.

# RULES AND GUIDELINES OF PRAIRIELAND RV PARK

Check in / check out: 11:00 am. Campsites must be empty of all personal property when you check out.

Only one camping unit (tent, tent-trailer, camper, camper-truck/van, camping trailer or motorhome) permitted in each campsite.

Alcoholic beverages may be consumed in the permit holder's camping unit, and on their assigned campsite, in accordance with *The Alcohol and Gaming Regulations Act, 1997*, as per Section 107 (1) per 139(1)

The permit holder, their family and guests shall comply at all times with all permit conditions and regulations. The permit holder is responsible for the conduct and behaviour of their family and guests. Everyone must observe all campground regulations and conditions. Rowdy behaviour or excessive noise is not permitted at any time.

Permits must be visibly displayed in/on door of unit.

Each permit is valid for one site only. Site size 15' x 35'.

## **Pets:**

Owners are responsible for the care, control and behavior of their pets at all times.

- Promptly clean up after your pets.
- Keep pets on a leash (not exceeding 2 meters in length) at all times.
- Keep pets quiet and ensure they do not become a nuisance, danger or threat to the comfort or safety of any other person.
- Ensure that pets do not damage or destroy any property.

Fires are NOT permitted.

Please leave your site in the same condition as it was when you arrived. Thank you for helping to keep our park clean.

**QUIET** hours between 10:30 p.m. and 7:00 a.m. Remember that voices carry when all is quiet, so please be considerate toward your neighbouring campers. Sound levels must be maintained at a tolerable level.

Mini bikes, dirt bikes and ATV's are **NOT** permitted in the park.

Discharge of firearms and fireworks is prohibited.

No bicycle riding after dusk.

***Management reserves the right to evict anyone from the campground for detrimental conduct or failure to observe park rules and regulations.***
