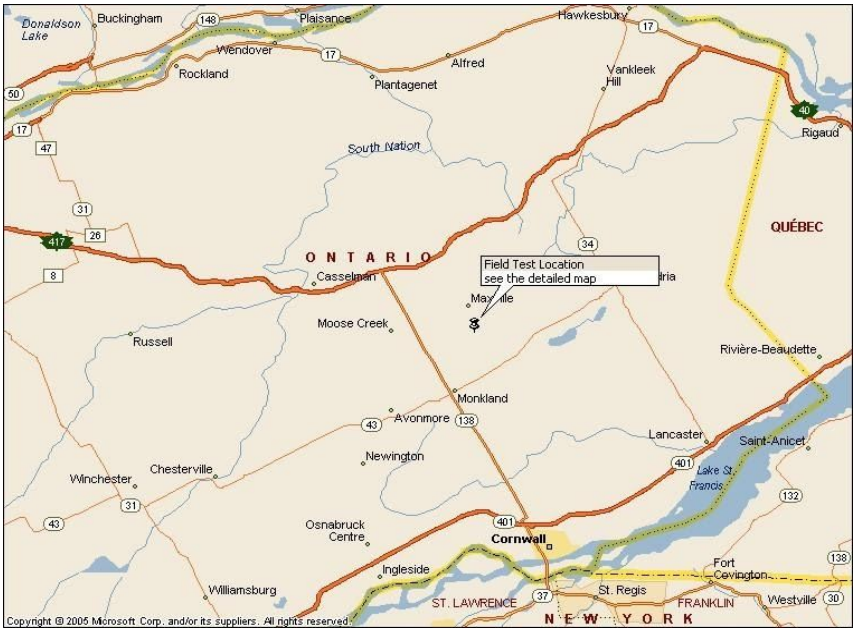


Maps to Ambertrail

Indignities: It shall be the duty and obligation of the Ottawa Valley Pointing Dog Club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Field Chairperson shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating this has occurred.

Courses and Game: Chukar, pigeons, pheasant or any combination there-of will be used in all field categories. A recognized game bird (duck, chukar, pigeons or partridge) will be used in the FDX water retrieve. Ducks will be used for WDJ, WD, and WDX tests. Shooting will be by "Official" gunners only. FDJ, FD, FDA, FDX and FDXCH courses will be a single course with bird field. FDJ and FD dogs will be run individually. FDA, FDX and FDXCH dogs will be run in braces. FDJ handlers must carry a starter pistol. For safety, FD, FDA, FDX and FDXCH handlers must wear blaze orange clothing items.

Fees: \$60.00 per field entry and \$55 per water entry per day or \$110 for both on the same day prior to the closing date of September 8th.
Day of test entries \$70 per field entry and \$65 per water entry or \$130 for both on the same day.

Fees are payable in Canadian funds only.
A listing fee of \$11.30 as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (E.R.N.) is not shown on the entry form.

- Entry** Close the day of the tests or when the tests are full.
- Close:** All entries must be paid in full prior to your test – Saturday 12th September 2020.
*****NO bitches in heat will be permitted on the test grounds...for any reason*****
- Draw:** Running order draw will take place at the home of the Event Chairperson at 9:00 PM 10th September, 2020. The drawing will be random and specific times cannot be assigned. The owners of the first three dogs to be run on Saturday will be notified by telephone or E-mail. If two dogs owned by the same person draw consecutive numbers, the second dog will be redrawn.
- Prizes:** KKC blue flat ribbon to each dog earning a qualifying score. OVPDC will have rosettes for 1st-4th place. If running one test the ribbon and score sheet shall be given out shortly after your dogs' test, this gives you the opportunity to leave due to the COVID health guidelines.
- Meals:** Due to COVID-19, there will be no lunch served. Please bring your own snack/lunch and water for you and your dog.
- Camping/
Hotel:** Limited camping for judges and OVPDC executive only. *No camping for participants unfortunately due to Covid-19.* Please check for dog friendly accommodations at the Microtel in Casselman ON if you require them.
- Other:** No training of dogs on the grounds during the test. It is also recommended that dogs competing have current immunization status.

COVID-19 SAFETY MEASURES:

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization.

1. Do NOT attend these tests if you are feeling unwell or exhibiting any COVID-19 symptoms.

2. No one is allowed on the grounds other than individuals who are handling a dog, judging, or volunteering in an official capacity. No spectators and no children. To keep the number of people in attendance at these tests to a minimum, only 1 person - the handler - is allowed to attend, with the following exceptions:

a. Handlers who are minors, i.e., under the age of 18, who require a parent / guardian to accompany them.

b. Handlers who require another person to drive and/or accompany them due to health, mobility, or other legitimate reasons.

3. Physical distancing (minimum of 2 meters / 6 feet) requirements from people who do not live in your home will be in effect at all times for everybody.

4. At present, individuals are not required to wear a mask outdoors BUT all handlers, judges, and volunteers etc. are asked to bring / have a face mask on their person for everyone's protection if the 2-metre rule can't be adhered to.

5. Bring your own:

- water, lunch, snacks. NO communal coffee or lunch will be provided;
- water for your dogs;
- lawn chair;
- hand sanitizer but do not share it with others.

6. Hand sanitizer, paper towels and spray disinfectant will be situated by the Porta Potty. Signs will be posted on the Porta Potty regarding using this stuff! Read the signs and comply!

7. Please respect, at a minimum 2 meter distance, where the Test Secretary is situated for her safety. Please respect this area and do NOT enter her workspace.

8. As soon as you are done for the day, ask for your score sheet & ribbon(s) if applicable & leave the test site.

9. The Field Chair/Marshal/Secretary has the authority to enforce the safety measures imposed for these tests.

Anyone failing to comply will be asked to leave the grounds immediately and forfeit all runs for the day.

SPECIAL NOTE: FIELD DOG TEST RULES & REGULATIONS

para. 18.7 It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or competitor at a Field Dog Test or Water Dog Test is not subject to indignities. The Field/Water Test Chairperson shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

NOTE: NEW Paragraph 11.3 It is mandatory that judges, handlers of the working dogs and marshals wear a blaze orange outer garment (vest or jacket) and blaze orange head gear in any tests where shotguns are used. The requirements also apply to any gallery members on the course.

CKC Non-member Participation Fee

An annual non-member participation fee for awards and titles will be charged to Canadian non-members of CKC. In order to protect the awards/titles earned, the non member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

AGREEMENT OF EACH ENTRANT In consideration of the acceptance of my/our entry (ies) and of the holding of the test and of the opportunity to have the dog tested and to win ribbons or trophies, I/we acknowledge and agree as follows:

- 1) The Ottawa Valley Pointing Dog Club (OVPDC) may refuse any entry for just cause, which the OVPDC deems to be sufficient.
- 2) Field tests have certain inherent dangers associated with them, including, without limitation, those due to the presence and/or use of firearms, and as such any person participating in the test or being present on the test grounds assumes the associated risks.
- 3) To hold the Canadian Kennel Club (the "CKC"), any CKC approved judge, the OVPDC, its members, directors, officers, agents, committee members, test secretary, official gunners at the test and the owners or lessor of the test grounds and any employees of any of them (collectively, the "Club"), harmless from:
 - a) Any claim for loss or injury which may be caused or alleged to be caused directly or indirectly to any person or thing by any act of any dog I have entered in the test, or am responsible for, while in or upon the test grounds, or near any entrance to the test grounds;
 - b) Any claim for loss of any dog I have entered in the test, or am responsible for, by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether the loss, disappearance, theft, damage or injury is caused or alleged to be caused by the negligence of the Club or any other person or any other cause or causes;
 - c) For bodily injuries, including death at any time resulting from bodily injuries, sustained by any person or persons, including myself/ourselves, any minors for whom I/we is or are responsible or on account of damage to property arising out of or in consequence of my/our or their participation in the test or presence on the test grounds, however such injuries, death or damage to property may be caused and whether or not caused or alleged to be caused by negligence of the Club or any of them or any other person; and

I/we personally assume all responsibility and liability for any such claim; and I/we further agree to assume the sole responsibility for and agree to indemnify and save the Club harmless from any and all losses and expenses (including legal fees) by reason of the liability imposed by law or a court of competent jurisdiction upon the Club or any of them for any of the foregoing.

I/we agree to be bound by this Agreement of Each Entrant printed in the Official Premium List. I/we certify and represent that the dog entered is not a hazard to persons or other dogs.
