**INFORMATION FOR EXHIBITORS**

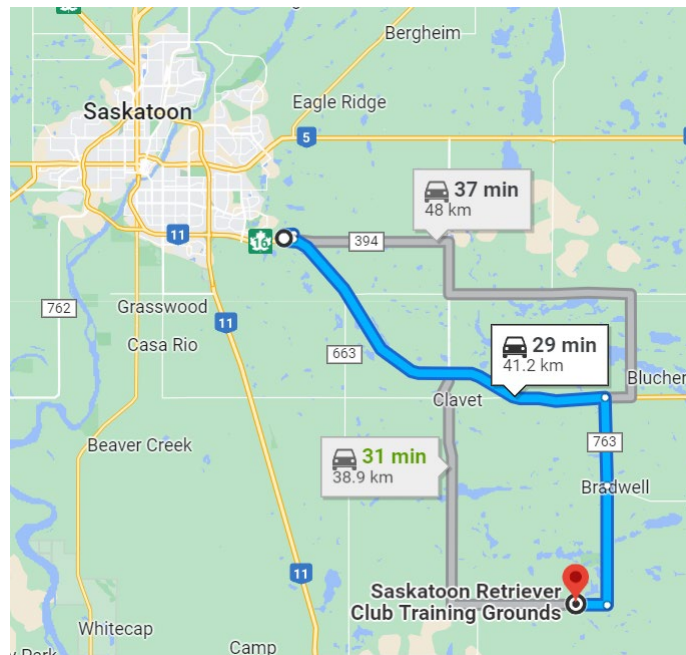
1. Entry fees will not be refunded after Thursday June 16, 2022
2. Dogs without an individual registration number (RN) or event registration number (ERN) are required to pay a \$10.50 listing fee (GST included)
3. A non-member participation fee, for awards and titles, will be charged to Canadian non-members of CKC. Exhibitors have the choice to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in cancellation of awards and titles
4. Female dogs in season are not eligible for entry
5. Scratches will be refunded at the SRC Working Certificate Committee discretion and may incur a \$10.00 cancellation fee
6. Draws for running order will take place upon the closing of entries
7. The catalogue with running order will be posted online (DogShow.ca, Canuck Dog and SRC website) by the evening of the day prior to the event date
8. Local birds including but not limited to ducks, pheasants, chukars or guinea hens may be used.
9. If a dog is not present within 15min of being called to the line it may be disqualified
10. CKC Rosettes will be awarded to all qualifying dogs in each event
11. All throwers, judges and handlers are required to wear dark or camouflaged clothing
12. There shall be no training of dogs on the test grounds starting 24 hours prior to event and ending upon event completion

## NOTICE TO EXHIBITORS

1. It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
2. The Saskatoon Retriever Club will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise. Furthermore, the Saskatoon Retriever Club will assume no liability in the event of an accident or other misfortune to event participants, bystanders, club members, workers or other individuals using the property for any purpose
3. **Release and indemnification of Landowners and the Saskatoon Retriever Club**  
By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all his heirs, executors and assigns.

## **COVID REGULATIONS: SASKATOON RETRIEVER CLUB EVENTS**

**For the safety of everyone involved, the Saskatoon Retriever Club asks that all adult participants and spectators be fully vaccinated (at least 2 doses) against Covid-19 before attending this event.**

**Officials and participants are required to follow local and provincial Covid regulations.**

1. Practice physical distancing, maintaining 2m between individuals whenever possible.
2. Hand sanitizer will be provided by the club for judges and workers. Anyone wishing to wear a mask should bring one for their own protection.
3. In some events handlers may be asked to show their bird to the judges and then deposit it in a pail next to the line
4. Special instructions from judges will be posted in the holding blind.
5. Realizing that trials are an opportunity to see friends that you may not have seen in a long time due to COVID, it is recommended that you refrain from hugging or shaking hands or other close contact with individuals not in your household. Maintain physical distancing.
6. Judges and throwers will each be given a bag lunch and drinks. All other workers and marshals should provide their own lunch and should maintain adequate distance from others while eating.
7. If possible, awards will be announced outside with physical distancing required and ribbons can be picked up from the awards table.
8. Participants are encouraged to gather outside to eat during the BBQ.
9. There will be hand sanitizer available in each outhouse. Disinfectant wipes will be in each outhouse.
10. Camping in the campground area will be allowed. It is recommended that socializing be limited to outdoor gatherings.
