Day of Show Entries: - Dogs that enter performance events 1 hour before the trials begin will be judged within each class of competition but will be placed at the end of each class of competition. Dogs entered on day of show will not have their entry recorded in the catalogue. All dogs entering must be eligible for competition at the time of the trials as set out in the rules of the CKC and must possess a CCN number.

Junior Handling

Junior Handling Conformation (Saturday) will be held in the first available ring at approximately 12:30 pm. Junior Handling Obedience (Saturday) will be held immediately following the Regular Obedience competition but before the Rally competition starts at approximately 9:40 am in the obedience ring. Judges for each event will be announced at the shows/trials on each day of competition. Entries for both events must be in the hands of the Show Secretary at least 1 hour before the competition. Cost is \$5.00 per Junior per event. Dog must be entered in a regular class in the shows or trials or entered as Exhibition.

FROM THE AVALON KENNEL CLUB

A fundraiser will be held by the AKC throughout the weekend. We have a beautiful framed print to offer. For \$10.00 per chance you will receive a half of a playing card. The other side of the playing card (with your name and number) will be placed in a bin for the draw. The draw will be held at dinner later on Saturday night if all the cards are sold throughout the day. The jokers are included so you have a 1 in 54 chance of winning a beautiful framed print donated by artist Mary Dunphy. The print will be on display at the shows.

You are welcome to come along and help with set up to get first dibs on good spots <u>but only</u> after the shows set up is complete.

This is a **<u>self-clean show</u>**. Product and cleaning materials will be available for your use both inside and outside of the venue.

The AKC will be having a **Show Social** at P.J. Billington's at 7:15 pm on Saturday, May 16th. All are welcome to attend. Please advise the show secretary by 4 pm on Saturday if you intend on joining us. Seating is limited so advise early please. Please see the show secretary on Saturday or contact Mary Dunphy. The orders are by menu and are offered by individual invoicing.

FROM Buckmaster's Circle Rec. Centre

NO sprays or other grooming products are to be used in the set up areas. All sprays and products must be put on the dogs outside of the venue. If you damage the floor beneath your set up you will be held responsible for its repair. Just a reminder that CKC tells us that dogs must be shown in their natural state without addition of any sprays, or products which alter or enhance the natural coats of the breeds.

NO smoking inside the venue or outside of the entrance/exit doors of the building.

Additional parking is available on Ricketts Road on Saturday and Sunday. Please do not block anyone's driveway in the area.

_ On the day of the show/trial, the show/trial superintendent will be in charge of the show/trial which is to be governed by CKC Rules and Regulations

_ Only dogs properly entered in the show/trial will be admitted.

_ The building will be opened 1 (one) hour before the start of the show/trial.

_ Dogs may be removed from the building when not required for further judging. Dogs must not be left in the building overnight.

_ Dogs and their handlers should arrive in adequate time for their breed judging (allowing for absentees) and will be excused from each show when not required for further judging. It is the responsibility of the exhibitors/handlers to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs is not possible and handlers with several breeds must arrange alternate handlers if judging times for their breeds conflict. Judging will proceed without any dog not present when called by the ring steward.

_ The show/trial committee and the Avalon Kennel Club will use due care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, or assume any liability, in the event of an accident or other misfortunes to either dogs, exhibitors or patrons.

_ There is no security services provided at the venue, therefore, property left at the show/trial grounds is done so at the owner's risk.

_ If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or complete the show/trial, no refund of entry fees will be made.

_We regret that trailer hook ups <u>will not</u> be available at the show/trial site.

_ It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation/Trials Show Committee Chair shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit upon receipt of a report indicating that this has occurred.

_ The show/trial grounds are defined as the confines of Buckmaster's Circle Recreational Centre, Buckmaster's Circle, St. John's, NL.
