Field Trial Eligibility:

Only Whippets may be entered. All dogs must be one year of age or older on the day of the trial. Dogs not registered with the CKC must pay a \$10.00 Listing Fee per trial / per day until CKC registration is obtained. Altered and neutered hounds may compete. **DOGS PRESENTLY DISQUALIFIED / DECLARED INELIGIBLE IN CANADA OR THE US CANNOT ENTER.**

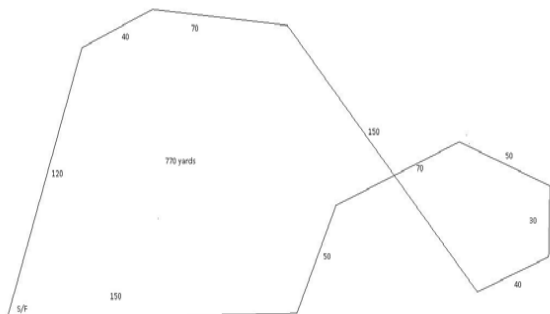

Course Plan:

The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. Course will be reversed for finals and again for run-offs and BOB. They may be changed to suit field conditions.

Course Plan



Certification runs: Will NOT be available

Equipment: A continuous loop machine with white and/or coloured plastic streamers will be used. Back up equipment will be on site.

Conditions: Stakes will be split when there are more than 24 dogs entered at the time of the draw. All dogs will run twice in braces or trios unless excused, dismissed or disqualified. Bitches in season or lame hounds will be excused and any entry refunded if notice is given prior to roll call. Hounds not present at roll call will be scratched and entry fees will NOT be refunded. Handlers must use slip leads when starting their hounds. Muzzles may be used at owner's discretion. All hounds will be slipped from a standing start.

PLEASE TAKE YOUR GARBAGE WITH YOU

This is the first trial where you are encouraged to NOT pick up your dog poop, please walk your dogs at the edge of the field so nobody steps in it.

Judges:

A judge officiating at a field trial under these rules and regulations (CKC) shall NOT be subject to indignities of any kind during the progress of the field trial. It shall be the duty and obligation of the club holding the field trial to see that this regulation is effectively carried out. The Field Trial Chairman shall promptly report to the Canadian Kennel Club any infringement of this regulation, and the Discipline Committee shall have the power to take such action as it deems fit on the receipt of a report indicating that this regulation has been violated.

Stakes offered:

Open: for dogs that do not have FCH

Field Champion (FCH): for dogs that have FCH title

Veterans: for dogs 7 years of age or older by date of trial, regardless of title

Winners of Open, FCH and Veteran Stakes may run off for BOB, or forfeit run off

Unofficial Stakes

Must pass roll call to run; Max 12 entries as per CSFA rules

Singles: dogs must run singly, preliminary and final runs

Puppy: ONE run only, to be run at break or following finals. Indicate age group on entry form 3-6, 6-9, or 9-12 months

Trophies and Awards:

Rosette and/or trophy will be awarded to BOB, 1st to 4th and NBQ in each stake

CKC Non-Member Participation Fee Policy:

A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

Directions: (GPS 45 04 09.44N 74 16 37.36W)

From 401:

Take exit 750 (Morrisburg), go NORTH (toward Winchester) about 22 km Turn R. onto River Rd. (1st rd. after Cass Bridge; previous Rd. = Nesbitt, also known as airport rd., on R. also); Cass Bridge Cheese (& ice cream!) House is directly opposite River Rd. Go 4 km along River Rd.; there will be a bridge across the river (South Nation) on your R. This is Nation Valley Rd. Take this bridge, keep on curve to the L. 12758 will be the 1st place on R. after that curve. Go past the house (2 story red brick), past the barn, drive on lane way along fence till you see the field.

From Ottawa:

31 south (Bank St.) to 4 km south of Winchester (do not turn into Winchester, stay on 31); turn L. onto River Rd. opposite that cheese house, then as above.

From Kemptville:

Hwy 43 east to 31, turn R onto 31 (south) - then as above.

From Alexandria or Monkland:

Hwy 43 west to Chesterville; just past 1st exit off 43 for Chesterville, Nation Valley Rd. is on the L., Eastern Ontario Graphics on SE corner. 12758 is about 5 km down, on the L.

From Show site (Woodlands campground):

Turn R. on Long Sault Pkwy (2.4km), turn L. on CR 2 (1.1km), turn R. Dickinson Dr (CR 14) -signs for ON401/FINCH (4.7km), turn L. on CR 18 (4.9km), turn R. on CR 11 (15.3km), turn L. CR 43 (4.4km), turn L. Nation Valley Rd (4.9)

From Coursing to Show site:

R out of driveway onto Nation Valley Rd; R at T intersection onto HWY 43. From 43 turn R onto 11. At T, turn L onto 18. At next T, turn R onto 14 (Dickinson Dr). At next T, turn L onto HWY 2. Then R onto Long Sault Parkway. Woodlands campsite is on the L

Field Conditions:

- No shade on field or camping area ALL fenced, well away from roads.
- Water tub will be available for dogs.
- Grass will be farm length (cut or grazed down, not mown to golf course length); there will be sheep manure on the field.
- Very flat.

Camping:

Camping on the field available (no hookups); if weather is extremely wet or extremely dry confirm ahead please. For campgrounds in the area contact Kate.

Attention All Exhibitors:

- You need an up to date rabies certificate dated no less than 30 days but no more than three years to cross the border
- You need a passport for each individual in your vehicle in order to return to the United States.
- Our bank will not accept cheques marked "Payable in Canadian Funds". We suggest sending an American cheque and either replacing it with cash on the day or sending money order in Can \$
- NWCC appreciates everyone's co-operation in keeping our site clean.
- There will be a \$5.00 fine for any loose dog interfering with a course in progress.
- Flexi Leads and Electronic Collars are not permitted on the field.
- Foreign born and foreign owned dogs may compete with an **Event Registration Number (ERN)**. This must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation and can be obtained by submitting a copy of your foreign certificate of registration and a fee of \$57.60 with a letter of request to the CKC. This ERN replaces a CKC individual registration number for American Owned dogs entering events only and is not subject to taxes

NOTE: a CKC Listing Fee of \$10.00 per dog is payable for each dog that does NOT have a CKC Registration Number, Performance Event Number or Event Registration Number. **This \$10.00 is in addition to the regular class entry fee.**

Championship Points in Regular Stakes:

Shall be awarded on the basis of the following:

1 st place	4x #hounds in Stake (max 40 points)
2 nd place	3x #hounds in Stake (max 30 points)
3 rd place	2x #hounds in Stake (max 20 points)
4 th place	1x #hounds in Stake (max 10 points)
NBQ	No points
