### COVID -19 SAFETY PROTOCOLS August 8<sup>th</sup> 2021

- Mask wearing is recommended. Masks are requested if not fully vaccinated. Please respect the judge's wishes whilst in the ring.
- Physical Distancing of a minimum of 2 metres to be maintained when possible.
- Frequent hand washing and sanitizing
- Washroom touch points to be wiped upon entry and exit.
- Only 1 Dog/Handler team in the ring, and the next Dog/Handler team in the waiting area, allowed beyond the crating area. All other practice and warm up to be outside.
- > No socializing or spectators allowed in the trial ring area.
- Armbands to be picked up from the Secretary at check-in upon receipt of signed Covid-19 waiver form.
- > Payment of entry fees (exact change) to be handed to the Secretary at check in
  - Sanitizing of all handler touch points within the ring will occur before the next handler enters the ring
  - Sanitizing ring steward touch point will occur with a change of personnel.
  - Sanitizing all touch points in the building will occur between the 2 trials.
