**Whether coming from the United States, Quebec (or further east) or Nova Scotia on the Trans Canada Highway**

**Take Exit 467B off Trans Canada Highway (Shediac-Miramichi) to the four lane Highway (Veterans Highway) Moncton to Shediac**

**Take Exit 31B to Route 11 North (towards Miramichi)**

**Take Exit 7 (just after river) ~ at Stop Sign turn left and go over highway to Stop Sign. Turn left onto Shediac River Road. Go around large Right turn, travel about 0.5 Km to first street on left (Aurel Poirier Dr). Go to very end of the Road and turn Left onto Ch Petite Pre.**

**Drive to the very end of the road and you are there.**
