➤ **Location:** Exhibition Park, Hwy 333, Halifax, NS

- **Please remember to bring your exhibitors tickets or a list of your armband numbers with you. The armbands for the specialty show and the HKC show are the same.**
- Judging will start promptly and adhere as closely as possible to this schedule.
- It is the responsibility of the exhibitor to be at ringside when their classes are called. It is not the responsibility of the ring steward to locate dogs. **Judges will not wait for any dog or handler delaying a class.**
- The figures following the Breeds indicate the number of dogs entered in - (1) Male Classes, (2) Female Classes, (3) Specials Only, Male & Female. The figure before the breed is the total entry.
- Time for Conformation Judging is based on 20 - 25 dogs per hour.
- It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Section 19.7 Dog Show Rules)
- No dogs are to be left in the building overnight.
