Notes from your Trial Chair:

IMPORTANT INFORMATION FOR EXHIBITORS

- 1) Only park in the designated area. Along the trees, and back behind the barns.
- Dogs must be on a leash at all times except when in the ring and at the warm up jump. No "Flexi" lines allowed on the property for safety reasons.
- 3) Food is not permitted in the course area or within 10' of the ring gates per CKC Rules. Ring gates are available to be closed on request.
- 4) Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is not dog aggressive.
- 5) Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
- 6) No smoking, vaping or cannabis use is permitted on The Poodle Farm property.
- 7) Please do your best to keep barking to a minimum when not warming up and/orin the ring.
- 8) Food will NOT be available on site, you may want to bring your own packed lunch. Local Tim Horton's, grocery store and pizza are about 5 minutes from the trial venue. Water and cold beverages will be available.
- 9) There is limited shade for vehicles. Shade Tents may be set up, please stay 15 feet from the agility ring fence when setting up and social distance 6 feet away from other competitors.
- 10) Water/pool will be available for the dogs.
- 11) Please ensure your dogs are not running in the planted adjacentneighbors' fields. You may walk them up the paths however please be aware of tractors, ATVs and other motorized vehicles and other local residents with their dogs/pets as we do not own the adjacent property.
- 12) Every competitor is expected to volunteer, please review the sign up sheet, you may trade with people, rings will not start till assigned volunteers are in place. A full trial, makes for a nice trial when everyone helps ③
