**ENTRY INFORMATION:**

- For Match [ref. <https://www.ukcdogs.com/club-events>], dogs **do not have** to be UKC registered, a Performance Listing (PL), or Temporary Listing (TL) number in order to participate;
- The judge does not need to be a licensed UKC judge; however they must follow all UKC rules, guidelines and policies in accordance with that event. [ref.: <https://www.ukcdogs.com/docs/showevents/lure-coursing-rulebook.pdf>];
- Each dog will run at least twice unless dismissed, excused, or withdrawn by the owner;
- Muzzles. Dogs may wear muzzles at the owner's discretion;
- Collars. Catch collars, if used, must be flat buckle type collar, and not have any tags, ornaments, or anything hanging that might interfere with the dog. Any other type of collar is prohibited.

**ENTRY FEES**

Pre-entry \$20.00 each entry, Add'l dogs same owner \$15.00.

Day of Meet: \$30.00 per dog, per entry. No Discount of Day-of-Meet Entry.

## **REFUND POLICY**

Lame dogs and females in season may not be entered. Entry fees will be refunded if is notified prior to Check In.

## **JUDGING**

A standardized course plan of approximately 400 to 700 yards will be used, and each part of the course demonstrates speed, agility, or endurance. Each skill is judged on one third of the course; speed is judged on the run- up (first portion), agility is judged through the agility portion (second portion), and endurance is judged on the return to the start (third portion). Judges will indicate the winner following each course. Ties will be re-run immediately, if necessary. Dogs will have at least a 20 minute break between courses.

Ribbons will be offered for all placements. Trophies will be awarded for Regular Stakes | Best of Breed.
