



## NORTHERN ALBERTA POINTING DOG CLUB OFFICIAL FIELD TRIAL PREMIUM LIST MAY 19-20, 2024

The Northern Alberta Pointing Dog Club will hold a Canadian Kennel Club sanctioned field trial for **all pointing breeds** near Buck Lake, Alberta on May 19-20, 2024. It will be held under the rules of the Canadian Kennel Club, 5397 Eglinton Ave. W., Suite 101, Etobicoke, ON M9C 5K6. This trial will be held in conjunction with the German Shorthaired Pointer Field Club of Alberta field trial May 18-19, 2024.

### STAKES

**All stakes will be foot handled. Judges will be mounted on horseback or motorized vehicle. Chukars will be released in all stakes except puppy. Native partridge and grouse may be present.**

#### **LOCATION:**

The NAPDC is grateful to have permission from the Government of Alberta and the Buck Mountain Grazing Lease Association to use these grounds. A map with directions to the grounds will be provided to participants when the running order is distributed. Your cooperation in keeping the grounds free of litter is essential. No smoking will be allowed on the trial grounds outside your parked vehicle or RV.

Note: **All persons who enter the grounds will be required to sign a waiver prior to entering or engaging in any activities on these grounds. We need to have the waivers prior to the start of the trial. #### **GENERAL INFORMATION:**

1. Running and handling: All stakes are walking only. There will be no horseback handling. Members of the gallery may be on foot or mounted, but must follow the judges.
2. CKC Pointing Breeds Field Trial Rules & Regulations (January 1, 2023) state the following:  
**2.6.1** At the judge's discretion a modification to the exercise/routine may be made to accommodate a handler with disabilities providing that such modification does not aid the dog's performance.  
NAPDC welcomes the participation of all handlers. Anyone wishing to rely on a modification including a motorized conveyance to support their participation should advise the Field Trial Secretary in advance and must receive the judges' approval and direction in advance of running their dog.
3. Senior stakes and Open Derby will be 30 minutes in length. Open Puppy will be 20 minutes. In the event of unforeseen circumstances, Derby may be shortened to 20 minutes and Puppy may be shortened to 15 minutes.
4. A scout, if used, must be on foot. A scout may only leave the gallery with permission of the judges and solely for the purpose of finding a dog on point. A scout is not permitted to act as a second handler.
5. Blank pistols .22 caliber or larger must be fired over all dogs with bird work in Derby and Senior stakes. Blank pistols will not be fired in the Puppy stake.
6. Tracking collars: Electronic tracking collars that meet the CKC guidelines and are lawful for use in Canada are allowed. Participants must declare to the judge that they are using the tracking collar. The receiver must be turned off and at the discretion of the judge, will be carried by the judge.  
**NOTE:** Under **Rule 11.4.10**, with the exception of tracking collars, collars worn in competitive stakes must be a type solely used for purposes of identification. That is, the normal dog collar with name plate attached **or** coloured collars used to distinguish between dogs in a brace. **Rule 11.6.6** states that no more than two collars may be worn by a dog.
7. Total entries will be limited to the number of dogs that can be run in the available daylight hours. Owners are advised to submit their entries as early as possible. In the event of high demand, the Field Trial Committee reserves the right to request owners limit their entries.

8. Collaring a dog away after game contact is allowed.
9. Bitches in season will be allowed to run only in the last brace(s) of the Amateur Shooting Dog. Please advise the Field Trial Secretary prior to running if your dog is in heat.
10. Backing tests: If a dog has placed in a senior stake and needs only to demonstrate a back to become a Field Trial Champion, the handler may request a backing test. The test will depend on the availability of birds. The cost will be \$20.00.
11. **Reminder:** There will be no exercising or training of any dogs on the grounds during the Trial. All participants must be familiar with CKC Rules and also the rules and provisions of this Premium List. CKC Field Trial rulebooks are available for purchase from the CKC. They are on-line at the CKC website for CKC members.
12. Please bring water for your dogs and horses.

**It is the duty and obligation of the trial hosting club to see that no judge, club official, volunteer, or any participant at an event held under CKC rules, is subject to indignities of any kind.**

**LUNCH:**

NAPDC will provide hospitality for all judges and volunteers.

**ACCOMMODATION:**

Dry camping at the trial grounds will be available Friday, Saturday, and Sunday night.

**PRIZES:**

Standard CKC rosettes will be awarded to the placing dogs in all stakes.

**IMPORTANT CHANGE - TCN Number (Previously Listing fees)**

A Temporary Competition Number (TCN) has been established by The Canadian Kennel Club and MUST ACCOMPANY the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form. This fee is \$10.50 (incl GST) per dog per each event entered during the field test and is in addition to the entry fee(s). Exhibitors should be aware that the CKC does not confer a title on any dog until it is registered individually in their records. Please visit [www.CKC.ca](http://www.CKC.ca) to obtain your TCN.

**ENTRIES:**

Entries will open at 6:00pm Tuesday, May 7, 2024, and close at 6:00 p.m. Tuesday May 14, 2024. Draw will follow immediately after closing at the home of the Field Trial Secretary.
