"It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

**Eligibility:** Purebred or mixed-breed dogs must be at least 6 months of age that are: (a) Individually registered with the CKC, (b) Have an Event Registration Number (ERN), (c) Have a Performance Event Number (PEN), (d) Eligible for registration with the CKC, or (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed (f) Have a Canine Companion number (CCN) if it is a mixed-breed.

**Bitches in Season:** Bitches in season shall not be eligible to enter the trial.

**Border Crossing:** A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

**Awards and Prizes:** Qualifiers will receive flat ribbons. Rosettes for dogs achieving a title during these events

**Site Information:** There will be no indoor crating at this trial site. Please bring water, shade and shelter for you and your dogs. There is a Subway, Tim Hortons, and McDonalds in very close proximity to the trial site. Trial will go on rain or shine.

### **For the Safety and Comfort of all**

- **Maintain a buffer between all dogs when passing by.... The more distance the better!**
- **All dogs must be on leash at all times unless they are in the ring. No Flexi/retractable type leashes or long lines to be used when walking dogs around the trial site.**
- **Dogs must be kept quiet and crated in between searches and potty breaks.**
- **Please don't gather around outside the doors as voices are carried and can be quite distracting. ABSOLUTELY NO DISCUSSING THE CURRENT SEARCH UNTIL ALL DOGS HAVE COMPLETED THEIR RUN.**
- **Venues are hard to come by so PLEASE PICK UP AFTER YOUR DOGS! We would like to trial at the offices again. Few places are so dog friendly.**

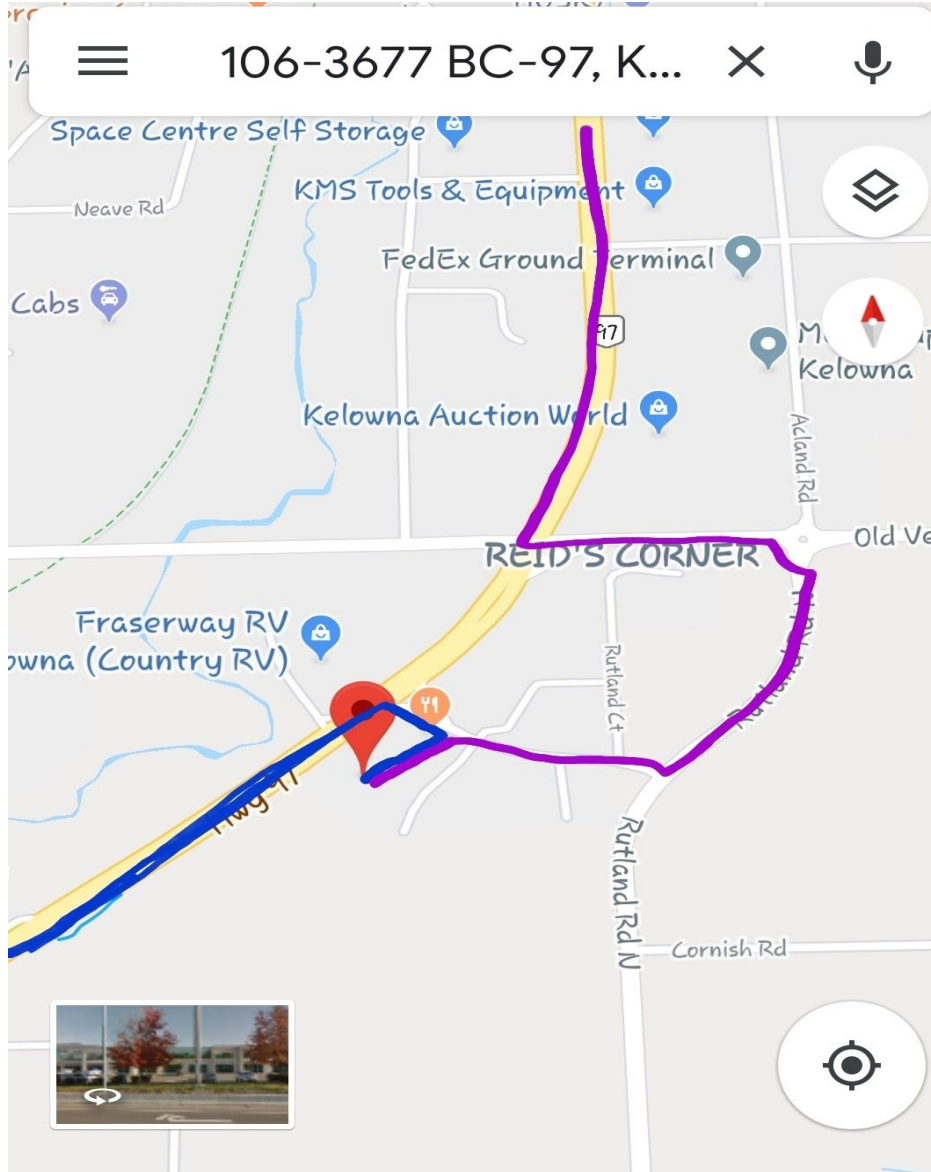
Please note: Entries received after the closing date will not be accepted. **Please make cheques payable to KELLY MORRIS. Do not post date cheques.**

Please note that there will be **no refunds after the trial closes** except for bitches in heat. Please provide a vet certificate dated within ten days of the trial date to be eligible for a refund.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds or pay online via DogShow.ca

**CKC Non-Member Participation Fee:** The CKC has a tracking fee for nonmembers. ## Directions to SERVICEMASTER RESTORE

**From Kelowna:** travel north on HWY 97 and turn right on Commercial Drive then turn immediately right at the Subway driveway and into the parking lot adjacent to the highway.

**From the north:** turn left (McDonald's side) onto Old Vernon Rd at Sexsmith Rd (Reids corner) intersection and get into the right lane (to enter the roundabout) so that you turn right onto Rutland Rd. At the next intersection turn right onto Commercial Drive and follow until you can turn into the Subway parking lot adjacent to the highway. Please note that there is no longer a left hand turn off of HWY 97 onto Commercial Drive.

## Shows and Trials Update IT-Related Delays

### **Miscellaneous Registrations**

Individuals who are awaiting a Miscellaneous Certificate Number (MCN) can temporarily enter events with closing dates no later than March 31, 2020 without a registration number, and the Canadian Kennel Club (CKC) will assign an MCN once the backlog has been cleared. All points and titles earned under the listed entries will be connected with the MCN once assigned.

### **Listing Fees**

Individuals waiting on registration numbers for recognized breeds can enter CKC events as "listed". Those paying listing fees due to the impact of the backlog are encouraged to forward copies of their entries to [information@ckc.ca](mailto:information@ckc.ca) with the subject line "Listing Fee Reimbursements". The body of the email must include the date the registration application was

submitted as well as whether it was submitted using the online Portal or emailed/mailed. Pending an assessment by CKC, a reimbursement of the associated listing fees will be issued.

### ***Premium Lists & Judging Panels***

CKC's judging panel approval process is currently delayed. In an effort to support clubs in publishing their Premium Lists so that their entries are not impacted, Clubs that are awaiting final approval of judging panels are encouraged to release their premium list marked \*SUBJECT TO CHANGE PENDING CKC APPROVAL\*. Exhibitors and participants should note that published Premium Lists may not be final.

### ***Temporary Competition Numbers***

With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a [Temporary Competition Number](#) (TCN). TCNs will replace the current system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

**TCNs will be required to enter all events with closing dates after March 2, 2020.**

### ***Event Results***

We understand and appreciate how important accessing event results are to our members and non-members who participate in CKC events. Providing access to event results is a priority for CKC.

2019 event results are current until August 28, 2019.

Currently, our highest priority and attention is focused on ensuring the required updates are made to the functionality of dog and litter registrations on the CKC Portal. Once this is resolved event results will be entered into the system and title certificates will follow. We appreciate your continued patience.
