- 🦴 Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C, Intermediate - 8 dogs/hour & Pre-Novice - 9 dogs/hour.
- 🦴 Rally Obedience Judging is based on 15 dogs/hour plus a 10 min walk-through time per class.
- ✓ Exhibitors are advised to check judge's sheets when posted and to immediately advise of any inaccuracies.
- ✓ It is the exhibitor's responsibility to know the rules pertaining to the trials.
- ✓ The precincts of the Trials will be the building and its surroundings.
- ✓ No prong or spike collars permitted on site.
- ✓ All exhibitors will be responsible for the clean-up of their own dogs anywhere on the trial site and surrounding areas.
- ✓ Venue will be open at 7:30 am on Saturday and Sunday. There will be no "Day of" Entries. Trial is full!

Trial Guidelines



Exhibitors will enter the venue at the front door where they will collect their armband and catalogue (if ordered). This is the only Entrance that will be used during the Trials. The side entrance will be closed.

Masks must be properly worn at all times and social distancing observed within the venue, during score/prize presentations and in the ring. Hand Sanitizer will be available throughout the venue.

Crating will be permitted in the large room connected to the front lobby. There will be a marked practice area set up in this room for one exhibitor at a time. Please be considerate and make this space available to the next competitor if they wish to use it.



All dogs must be crated unless they are in the practice area.



If, for some reason, your dog cannot be crated, please do not come into the crating area with your dog until you are ready to warm up your dog before your turn. In other words, you would be next in line to compete after the dog trialing, and the dog warming up in the Trialing area.

As in the past, we will provide a warm-up space in the trialing area for the next dog only waiting to compete.

There will be no crating available in the Trialing area.

We will not be allowing spectators in the trialing area for these trials.



Reminders pertaining to the Venue:



- No outdoor shoes in the Trialing area
- No food or drink (Water Only) in the Trialing area (blue floor)
- No smoking on the premises
- Only parking on the side of the venue building and in the parking lot
- No parking past the second side door as it is not owned by Ace It
- No exercising dogs on the opposite side of the street

The Dartmouth Kennel Club will be following the COVID guidelines outlined by the Nova Scotia government and this trial is being held in compliance with the 2022 CKC COVID guidelines for obedience and rally trials.

The running order will be posted on a board on or at the entrance to the staging area. Competitors should check off their numbers when they arrive to indicate that they are present. Rally score will be posted on the running order board. We ask for your understanding and patience. The board is the only place scores will be posted.

Competitors are responsible for being ready to be in the venue in time for their run. The stewards will not be responsible for finding competitors to inform them of their turn in the ring.

For dogs in Utility, Open, CDI, Rally Advanced, Excellent, and Master, there will be a table inside the ring for your leash, dumbbells, articles etc. Except for individual examinations of dogs, physical distance (2 meters) must be maintained at all times. Masks must be worn for all exercises and at all times in the ring.
