JUDGES' BIOGRAPHIES



Mr. Weng Woh Chan was the President of the Malaysian Kennel Association for two terms and has served as a director of MKA from 1994 to 2009. For his contributions towards the MKA, he was made a Honorary Life Member. A qualified Examiner for MKA judges Training Scheme and has served in the capacity of Chairman of Judges and Steward Sub Committee. Internationally he was a delegate for the FCI and AKU conferences, served in the Committee for AKU Judging Manual. In 2013, Mr. Chan was given the honour by FCI under the directive from President FCI Asian Section to inspect the new Iran Kennel Club. He has assisted in the formation of the Iran Kennel Club.

He has shown or bred Pekingese, Pomeranian, Miniature Pinscher, Pug, Miniature Poodle, Whippet, Toy Poodle, Lhasa Apso and Smooth Fox Terrier. He has shown many Champions and BIS winners. He is a licensed International All Breeds Judge of the MKA, AKU and FCI. He has given CACIB, CAC, CC or judged in 65 countries around the world in the continents of Asia, Australia, Africa, Europe, North and South America. Some of the biggest dog shows he has judged were the WDS Russia 2016 (judged BIG 6), Brisbane Royal 2016 (judged BIS),

EDS Norway 2015(judged BIG 9), Canadian Kennel Club Purina Invitational 2010, World Dog Show 2009 (judged BIG 9 Junior), Brisbane Royal 2004, Adelaide Royal 2006, Hobart Royal 2007, New Zealand National Dog Show 2003, the National Dog Show in Canada, Champion of Champions at the Kennel Union of South Africa and Pedigree/Ozdog Top Dog of Australia 2004.

He has judged specialties of the following breeds; Pekingese, Poodles (WDS-Solvakia & Russia, Sweden, Czech Rep, Japan, Taiwan, Denmark, Australia), Newfoundland (Germany), Pomeranians (Thailand, Russia, Indonesia, Japan, EDS-Sweden), Boston Terriers (Canada), Pugs (USA, Argentina, Canada, Thailand), American Staffordshire Terrier, Yorkshire Terriers, Labradors, Golden Ret, Thai Ridgeback, Thai Bangkeaw, Shih Tzu, Papillon, Siberian Husky, Beagle, Great Danes, Bernese Mountain Dog, GSD, Doberman, Rottweiler, American Cocker Spaniel, Pekingese, Chinese Crested Dog, Alaskan Malamute, Beagle, Fila Brasilla, Mexican Hairless, British Bulldog, Australian Shepherd, French Bulldogs, Shetland Sheepdog, Pembroke Corgi, American Akita and Dachshunds.

His future assignments are WDS 2017 Germany, Poland, Czech Rep, Croatia, Sweden, Finland, France, Denmark, Russia, Spain, Canada, Colombia, Mexico, Argentina, India, Thailand, China, Australia.



Roger and Paula Hartinger have been involved in purebred dogs for over 60 years. Their first breed was Great Danes but they are best known as exhibitors and breeders of Standard Schnauzers. They also owned, exhibited and bred some other breeds and as AKC Licensed Handlers they exhibited a variety of breeds in the US and Canada.

Over 40 years ago they were granted Judging approval by the AKC and both are now approved for all breeds. They have both judged extensively in all 50 States, many provinces in Canada and in over 25 other countries.

Both have been very involved as officers of all-breed clubs, specialty clubs and judges education clubs. They very much enjoy the dog show sport and are looking forward to their return to judge in Kamloops, especially since this will be the club's 50th Anniversary shows.



Mr. Ramón Podestá has been involved in purebred dogs since his childhood. At the early age of twelve he finished his first champion dog and at age seventeen he founded his world famous Von Haussman Kennel.

Ramon has owned and bred a record number of champions in many breeds including Latin American, North American, English, International and World Champions.

He has enjoyed breeding and exhibiting many different breeds with great success. He bred many Best In Show winners in the following breeds: German Shepherd, Afghan Hounds, Beagles, Whippets, Borzoi, Old English Sheepdog, Doberman, Dachshunds, Chow Chow, Irish Setter, Weimaraner, Dalmatian, Maltese, Pekingese, Standard Poodle, Miniature Poodle, Siberian Husky and American Cockers and many Best In Specialty Show winners Afghan Hounds at Chile, Argentina, USA, United Kingdom, France, Sweden, Germany, Netherlands, Italy, Russia and in some other countries.

Breeder of Top Dog All Breed in Chile in 2012, 2013, 2014, 2015, 2016(2), breeder of number one Afghan Hounds in England 2010 and 2011, Argentina 2015 and 2016, Brazil 2012, France

2016, Mexico 2016, Sweden 2016, Uruguay 2014 and 2015.

He is a former member of the Scientific Committee of the FCI serving three terms and is a past President of the Kennel Club of Chile. He founded the Pekingese Club and Working dog Club of Chile. And honorary member of Kennel Club of Chile.

He became an All-Breed Judge in 1978 and has judged in all Latin American countries, USA, Canada, UK, Finland, Norway, Sweden, Denmark, Russia, Oceania and many European countries. In his career he has judged at World Dog Shows, European Championship, Royal Shows and Asian International Dog Shows. In short he has the privilege of judging throughout the entire world around.

Mr. Ramon Podestá is the top breeder in the history of Chile, having the top dogs in the country for decades and holds the unbeatable record of bred-by Best In Show Winners.



Mr. Reynolds has been involved in the sport of dogs since 1956. As a breeder he was most involved with Scottish Terriers and his Renaldo kennel owned or bred over 30 Canadian and 15 American champions, many of whom were Best in Show Winners. He began judging in 1967 at the Ottawa Kennel Club show for Canada's centennial year and became an all-breed judge in the early seventies. He judges all breeds in Canada and has been permitted to judge all breeds by the AKC in the United States. His assignments have been on five continents and have included judging Best in Show at some of the most prestigious clubs including

Best in Show at Westminster in 2006, Best in show at the anniversary show of the Ladies Kennel Association in England and Best in Show at Australia's largest show "The Melbourne Royal". He has also officiated at World Shows in Switzerland and Germany as well as the Pacific International in Tokyo. He has had the great good fortune to officiate at over 70 national specialties in the USA. During 2016 Mr. Reynolds judged the American specialties for Irish Water Spaniels and the first specialty for Lagotti. He also judged Best in Show at the National Dog Show. This year was his fourteenth assignment at the Westminster Kennel Club as well as doing the first independent national for the Sloughi Association of America.

All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

The handler of the dog must be the owner of record or a direct family member. The owner must show the dog at all levels of competition. This competition is open to non-professionals only. Anyone who has handled dogs in a professional capacity in the past 2 years is not eligible to participate.

There are no additional fees for this event. Participants do not need to pre-register but the dogs must be entered in a regular conformation class.

TIME: Following Puppy in Group and Puppy in Show

Owner-Handled competition is an unofficial class. Participants do not need to pre-register but will need to inform the ring steward following the breed judging that they are the owner. The handler of the dog must be the owner for the classes.

The winner of BOH in breed may compete in BOH in Group unless the dog was already defeated at the Best in Group level, by another owner-handled dog. The winner of BOH in Group will compete in BOH in Show after the completion of Best Puppy in Show unless the dog was already defeated, at the Best in Show level, by another owner-handled dog that is entered in this competition.

RULES GOVERNING THESE SHOWS AND TRIALS

1. The club reserves the right to remove any person from the show. The show superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
2. Any dog excused by the show superintendent or veterinarian for any reason shall not, compete in any class for any awards for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability in the event of accident or other misfortune to either dogs, exhibitors, spectators, vendors or equipment.
4. A Judge or any person participating in any capacity at a dog show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **PACIFIC DAYLIGHT TIME.**
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the show grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by action of the Show Committee.

**ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO
KNOW AND ABIDE BY THE CKC DOG SHOW RULES**

ADDITIONAL SHOW INFORMATION

SECTION 8.6.1 & 8.6.3 OF THE CONFORMATION SHOW RULES AND REGULATIONS:

The authorities of any show may:

- a) decline to accept entries for just cause and/or
- b) refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- c) in the case of non-acceptance, the fee shall be returned with the reason for non-acceptance. No one shall have any claim or recourse against the organization holding the show, or any official connected therewith for the refusal of any entry.

CHAMPIONS AND CHAMPIONSHIP POINTS

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

*includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above.

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall NOT be included in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN) (3) have earned at least one 2 point win either at the breed or group level.

GRAND CHAMPION (GCH)

The title of Grand Champion may only be earned after the completion of the CKC Conformation Championship. Points for this title are only accumulated after the completion of the Conformation Championship and do not include the points earned in attaining the Conformation Championship. All required points are to be earned at the breed level. To be awarded a Grand Champion title, a dog must attain a minimum of 20 points which must include one Best of Breed and a minimum of two wins of at least two points each. a) Grand Champion Point System Points towards the Grand Champion title are awarded to the Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed Winner and the number of similar sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded as follows:

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

The title of Grand Champion shall not be awarded retroactively and all points towards this title must be achieved after the date of January 1, 2013. Points earned toward the Grand Champion title are to be recorded by the owner/handler on the form obtained from the Canadian Kennel Club. Once the owner/handler believes that their exhibit has attained the requirements for the Grand Champion title, the form may be submitted to the Canadian Kennel Club for verification and awarding of the title.

Grand Champion Excellent (GChEx) The title of Grand Champion Excellent may only be earned after the completion of the CKC Grand Championship title.

EXTRACTS FROM THE CONFORMATION SHOW RULES & REGULATIONS

CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

CHAPTER 8 - ENTRIES and ENTRY FEES

Section 8.3.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

(a) it is not a Miscellaneous breed

(b) if born in Canada, is eligible for individual registration

(c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered.

A listing fee of \$8.40 must accompany the entry of a "listed" dog at a show held under these rules.

Section 8.2: INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being cancelled.

Section 8.6.2: DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees. Clubs may refuse to accept entries from any exhibitor who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order, cash or certified cheque.

CHAPTER 14 - DISQUALIFICATION

Section 14.1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 14, Section 3 of the Conformation Show Rules and Regulations

CHAPTER 5 – SHOW OFFICIALS

Section 5.1.5

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

FOREIGN BORN MINIATURE DACHSHUNDS

Foreign-born Miniature Dachshunds if eligible for registration in the CKC, may be shown as a listed dog up to the age of one (1) year. The owner(s) must then submit an application for registration to the CKC within thirty (30) days. The listing fee for a Foreign-born Miniature Dachshund will be \$2.00 per show. Failure to comply with these rulings will automatically cancel all points on record.

Canadian Kennel Club Non Member Participation Fee (April 2011)

- A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
