SEC 18.7 OF THE CKC BEAGLE FIELD TRIAL RULES AND REGULATIONS states:

The Field Trial Committee Chair shall promptly report to the CKC any infringements of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”
