### **CHANGE OF JUDGE**

Ms. K. Hamel is unable to fulfill her judging assignment. With C.K.C. permission, the following changes have been made: Show #1 - Ms. K. Francis will judge all breeds in Groups 5 and 6 and the Groups at the group level. Show #2 - Mr. P. Machen will judge all breeds in Group 3.

Exhibitors affected by these changes may withdraw their entries, in writing, up to one hour before the judging of their breed.

#### **Directions from the Tunnel**

Turn left on to Ouellette Avenue. Take Ouellette out of the city. Exit right on Leamington 3B, go through two stoplights, on 2nd light turn left onto highway #3, follow to County Rd #34, turn right, go to first set of lights turn right, the fifth driveway on right, turn right go to the back. Colasanti's is 20 miles from Tunnel.

#### **Directions from the Bridge**

Leave Customs on Huron Church Road, go past McDonald's. Stay on Huron Church until it joins Highway #3. Follow Highway #3 to County Rd #34, turn right, go to first set of lights turn right, the fifth driveway on right, and turn right go to the back. Colasanti's is 25 miles from the Bridge.

#### **Directions from the 401**

Turn off at Comber/Leamington exit highway #77. Go through Comber, turn onto Highway #77, straight towards Leamington to Hwy #3, turn right, go to second set of lights, turn left onto County Rd #34, go to first set of lights turn right, the fifth driveway on right, turn right, go to the back of the property.
