### Listed Dogs

8.4.1 If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

(a) that if born in Canada, it is eligible for individual registration;

(b) that if not born in Canada, it is eligible for registration in the records of the CKC;

(c) that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered. 8.4.2 Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

8.4.3 The CKC has the right to require the owner of a listed dog to provide proof of the dog's eligibility for registration in the CKC. If it is found that the dog is not eligible, the CKC shall have the right to cancel all wins.

8.4.4 When a CKC registration number for a listed dog is received after the closing date and prior to the date of the show, this number may be added to the entry and noted in the marked catalogue. Listing fees will not be refunded. This then allows a dog who completes the requirement for championship status to be moved up to Specials.

### 8.7 Withdrawal of Entries

8.7.1 An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone, but either written or electronic notification must be received by the show secretary no later than the official closing date and time as stated in the premium list. If written or electronic notification is not received, the dog will remain entered in the show.

### 8.8 Fees

8.8.1 No dog shall be allowed to participate at a show unless the entry fee has been paid and any wins attained by a dog in violation of this rule shall be subject to cancellation. 8.8.2 Tendering of a dishonored cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

8.8.3 The owner or agent of any dog which has not been judged in its regular breed classes by 10:00 p.m. (on the last day of the show if more than a one-day show) shall have the privilege of demanding the return of the entry fee for the dog not so judged.

# Our Judges



## Elaine Ross

Having grown up in a dog show family with a Mother who exhibited and finished many American Cocker Spaniel champions, I saw and dreamed of owning and exhibiting German Shepherds. My first German shepherd won her CD title in three consecutive shows but unfortunately did not become a show dog. I persevered.

In the late 60's I began in earnest and to date there have been seven Canadian group winning females and one which went on to win a group in the United States. Several attained their US

## Michel Chaloux



I have been involved with German Shepherd Dog (GSD) all my life. My father registered our kennel with the Canadian kennel Club in 1955, the year I was born in Montreal, Canada.

Our breeding programs include German, American and Canadian bloodlines and we have bred to a number of the tops dogs from Germany, USA and Canada. We were involved for many years starting in 1970 with the Quebec branch of the North America

Schutzhund Association.

I'm a retired registered pharmacist, graduated from Montreal University in 1980.

My interest in GSD was mostly in handling dogs, finishing my first champion in July 1970 at the GSDC of Ottawa specialty show. I was the owner-handler of the first Canadian National Futurity Victor in 1974. I handled the Canadian Grand-Victor in 1981 and finished him in USA the same year.

I attended my first Canadian National for GSD in 1967 and my first US National for GSD in 1968.

In my handling career, I have finished more than 100 champions including 10 select titles (AOM) at the Canadian National. I won multiple B.I.S.S. and multiple group wins at some of the most prestigious all-breeds shows in Canada. I had the privilege to handle some of the top German Shepherds Dogs in Canada.

I've had the privilege to judge 7 times in the last 15 years, the National for German Shepherd Dog in USA, Canada and Mexico.

I received my license to judge GSD in 1993 and have judged

multiple specialty shows, Regional and National Futurity shows and all-breeds shows in Canada, USA and Mexico

I'm presently a CKC conformation judge for Sporting, Working and Herding group. I'm also approved to judge BIS. I have judged many all breed shows in North America and Australia.

I'm a bilingual person, speaking and writing French and English. My mother tongue is French.



## Dr. Terill Udenberg

Dr. Udenberg has been involved in the sport of exhibiting dogs for nearly thirty years, starting with Dobermans. After a short hiatus, returned with Standard Poodles and eventually including toy Poodles. He has been breeding Standard Poodles for over twenty years with the prefix "Tees" of Tees Blue Skies. He has had multiple Best In Show, and Best In Specialty winners, but loves exhibiting the young specimens of his breed.

He is a member of the Health Committee for the Pekingese Club of America. Dr. Udenberg was invited to speak at the National Pekingese Club of Great Britain( on airway re-

search) at their meeting with the Kennel Club of Great Britain, in regard to their impending changes in the Pekingese standard. It included many other short nosed breeds.

He has had the honor of judging many specialties in both the USA, Canada, and Australia, including: the Tibetan Terriers, Poodles, Boston Terriers, Pekingese, Pomeranians, Miniature Pinschers, Lowchen, Australian shepherds and others.

He is an avid volunteer in world disasters including Katrina, Guyana, Peru earthquakes, and in spay and neuter rather than strychnine poisoning of dogs in Fiji.

Dr. Udenberg, as a Veterinarian has special interest in genetically inherited diseases, and does critical care including Cardiology, Ultrasound, and Acupuncture. He is an avid outdoors man including biking, hiking, kayaking and extensive travel for diving along with his partner.

## Jack Kilgour

I am a second generation dog fancier. My Mom, Marvis Kilgour has bred German Shepherd Dogs since 1960. I started showing dogs in 1970. I have been active in and passionate about the sport ever since. I showed many different breeds of dogs while still a Junior Handler, but soon decided to specialize in German Shepherds Dogs.

My Kennel name is "Kijoda" (Perm. Reg'd). I bred my first litter of German Shepherd Dogs in 1980. That litter produced a Canadian National class-winning male who went on to become a champion and ROMC sire.

Over the past 30 years I selectively bred approximately 15 litters. These litters produced 25 Canadian and American champions, several Selects (National Specialty Award of Merit), a Maturity Victor, 2 Futurity Victrix and a Futurity Victor. I handled a Canadian Grand Victrix, more than 25 U.S. and Can. Selects), and more than 100 American and Canadian Champions.

I am a life member of both the Canadian Kennel Club and the German Shepherd Dog Club of Manitoba. I am also a member is the Canadian Dog Judges Association. In addition, I am also a member of the German Shepherd Dog Club of Canada, the German Shepherd Dog Club of America and The British Columbia German Shepherd Dog Club. I am licensed to Judge the Herding Group and the first half of the Working Group. I am on permit for the 2nd half of Working. In 2014 I had the honour of judging the German Shepherd Dog Canadian National. I am retired from breeding and handling dogs. I look forward to continuing in this sport as a specialty and all-breed judge, and as an educator for breed seminars.



### **Gordon Hayburn**

I moved, from the UK to Canada in February 2011, having been involved in dog showing activities at various levels for many years including committee member of the English Setter Society of Scotland and Golden Retriever Club of Wales. I was also the Secretary of the English Setter Society of Wales and the

Chairman of the Irish Red and White Setter Club of Great Britain. I have owned and shown the following breeds: English Setter, Irish Red & White Setter, Labrador Retriever and Golden Retriever. I judged my first show in 1996 and have judged many of the sporting (gundog) breeds in the UK. I award Challenge Certificates in the UK and am approved by both CKC and AKC to judge all of the Sporting Group and the top half of the Hound Group and on permit for the balance of the breeds in the Group. I believe that judging is a privilege and I am appreciative of those that show their dogs to me. I have previously judged at the Pacific Kennel Club Shows and had the best time. I would like to thank the committee for the return invitation for my first time judging the Hound Group in BC.



### **Dianne Ivey**

I have been involved in breeding and showing dogs since 1982 when we purchased our first Australian Terrier female. I have bred, along with my husband Ray, under the Maralinga prefix permanently registered by the CKC. We have bred or owned 15 Australian Terrier Champions, one of which

was BIS CH. Maralinga's Magic in Motion. Magic holds the record in Canada for 5 all breed BESTS IN SHOW for an Australian Terrier. Magic was the top Australian Terrier in Canada for 1986, 1987, 1988 and 1989. During the time we bred, our Australian Terriers placed consistently in the top five in Canada.

In 1990 Norwich Terriers were added to our household. Our first Norwich was imported from Denmark and became a Danish, Canadian Ch. We have bred or owned 34 Norwich Champions since 1990. I no longer breed or actively show. I am involved in the sport of dogs in various ways.

Currently, I am a member of the Canadian Dog Judges Association; a lifetime member of the Canadian Kennel Club, and a member and treasurer for the North Okanagan Tracking Club.

I started judging in 2000. I am licensed to judge all Terriers, Toys, Non-Sporting, Sporting, Working and now on permit for the Herding Group.

I have judged in Denmark, USA and Canada.



### **Barbara Turpin ...**

is a third generation dog breeder. Under the kennel name "Of Course", her family's Whippets are known for being true dual purpose dogs. They have excelled in both racing and showing for more than 50 years. Of Course Whippets are noted in the UK book, "Whippet's Today" and the US book, "The Complete Whippet".

Ms. Turpin has had Rhodesian Ridgebacks since 1995 and still holds fast to the family legacy of breeding dogs that are well able to perform the function for which they were bred. She was a panelist at the 2004 World Congress on the subject of Breed Specific Legislation, started the Rhodesian Ridgeback Club of Canada, has written numerous breed-related articles, is a past rescue coordinator and is a "Dogs in Canada" photography contest winner. She is also a novice judge, handling coach, doggy doula and self-taught canine herbalist. She has recently been invited to speak at the 2016 World Congress in Denmark.

Of Course Rhodesian Ridgebacks are known internationally as dynamic movers, dedicated performance dogs, excellent producers, and consistent winners in local shows as well as breed specialties. Of Course get is seen world wide succeeding in the show ring, on the coursing field, in obedience competitions, working as therapy dogs, doing scent work and even in Iron Dog competitions. Refusing fads, Ms. Turpin's dogs are typically true wheaten, standard size and nearly

always naughty.

Dedicated to the long-term preservation of the Rhodesian Ridgeback breed, Ms. Turpin's goal at the 2016 World Congress is to prompt discussions on where the breed is going and what needs to be addressed for the long-term good of the breed.



### **Marion Postgate ...**

is a CKC Licensed judge of the Toy and Non-Sporting groups, and all obedience and rally classes, judging in both Canada and the US. She has had a lifelong interest in dogs, starting in Juniors, and has showed a variety of breeds in conformation and obedience ever since. She

eventually bred Schipperkes on a limited basis, under the prefix Cantymere, and also has owned and exhibited Rottweilers.

She taught obedience classes at all levels for fifty years before retiring.

Ms Postgate has studied and lectured on dog structure and movement, as well as dog behaviour, since the 1970s, and given numerous seminars. She has appeared in court as an expert witness in numerous cases involving dog aggression.

Currently she is a member of the CKC Obedience Council. In the past, she served on the CKC Canine Good Neighbour Committee, and is a strong proponent of that program, as well as on Obedience and Rally Rules Committees.

She taught English, and is an accomplished amateur classical musician, playing the piano and violin.



### **Eugene H.J. Phoa, Q.C.**

I commenced judging in the early 1970's. I was first licensed to judge English Cockers, followed by several gundog breeds, at open show level by the Singapore Kennel Club, and then at championship show level by that Club over an increasing number of breeds and eventually on an all-breeds basis. Over the years until I

immigrated to Canada, I judged a few shows in the general South-East Asia region at championship show level. I immigrated to Canada in 1976 and, after a few years, was licensed as an all-breeds championship show judge by the Canadian Kennel Club.

I have judged in various countries around the world, including shows at Championship Show level in the Singapore, Malaysia, the Philippines, Japan, Canada, the United States, Australia, New Zealand, Argentina, Uruguay, Peru, Chile, the United Kingdom and Scandinavia. I have also judged National Specialties of the English Cocker in Canada (several times), the United States (approximately 400 entries), breed specialties of the Boxer (Uruguay), Alaskan Malamute and Siberian Husky (Australia), and large entries of English Cocker breed specialties in the United States, Australia, New Zealand, and the United Kingdom (including the London Cocker Spaniel Club Championship Show in the U.K. in 2015, where I had the honour of entry of about 300 bitches).

Although I have owned and bred various other breeds (including several Working, Toy and Terrier breeds) in my younger days, I have, since the mid 1960's, concentrated my energies almost exclusively on English Cockers. I came to own my first English Cocker with the purchase in 1959, in Perth, Western Australia, of a red bitch of "Treetops" breeding, and since then, have owned and/or bred many dogs which have earned their championships in Singapore, Malaysia, Canada, the United States, Australia, England, and several other countries.

In between times, I tried to practice law and had the honour of being appointed one of her Majesty's Counsel before I retired from my practice in 2009.

I thank the Pacific Kennel Club for the invitation to judge at its show, and look forward to the assignment.

## 8.6 Refusal of Entries

8.6.1 The authorities of any show may:

(a) decline to accept entries for just cause, and/or

(b) refuse to receive, or may remove any dog from the show building on account of disease or viciousness. A club declining an entry or ordering the removal of a dog from its show must report, in writing, all such matters to the CKC with a full explanation and/or reason within 14 days after its show has been held;

(c) in the case of non-acceptance, refund the fee with the reason for non-acceptance.

8.6.2 A club may refuse an entry from an exhibitor known to have tendered a dishonored cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

8.6.3 No one shall have any claim or recourse against the club holding the show or any official connected therewith for the refusal of an entry for just cause.

## 8.7 Withdrawal of Entries

8.7.1 An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by either written or electronic notification must be received by the show secretary no later than the official closing date and time as stated in the premium list. If written or electronic notification is not received, the dog will remain entered in the show.

## 8.9 Moving a Dog to Specials

8.9.1 A dog that is registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a championship in accordance with these rules but at the time of the closing of entries for show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

8.9.2 If it is established that a dog transferred to Specials Only has not completed the championship requirements, all awards will be cancelled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

8.9.3 When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to specials must be made a minimum of one hour prior to the scheduled start of the show for which the dog is being moved up to. The Show Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.

8.9.4 No dog may be transferred to another class except as provided in sections 8.2.5 and 8.9.1

## 12.2 Classes

12.2.1 Regular official classes at a CKC conformation show shall be as described in (a) to (k) of this section. All classes must be divided by sex (except for Specials Only). Only dogs entered in one of the regular, non-regular, or unofficial classes shall be allowed within the show precincts.

(a) **Junior Puppy Class Dogs** 6 months of age and under 9 months of age on the day of the show.

(b) **Senior Puppy Class Dogs** 9 months of age and under 12 months of age on the day of the show.

(c) **12-18 Month Class (All-Breed Shows) Dogs** 12 months of age and under 18 months of age on the day of the show.

(e) **Canadian Bred Class** Dogs born in Canada. Champions of any country are excluded.

(f) **Bred By Exhibitor Class** Dogs owned and handled in the ring by the breeder. The handler must be the owner/co-owner and breeder/co-breeder of the dog. The owner/ breeder must handle the dog in this class, but need not handle the dog for further awards. Should the owner/breeder be unable to handle the dog in this class, the dog may be moved to the Open Class (at least one hour prior to the judging of the breed in question. (63-06-13)

(g) **The Open Class** All dogs. Dogs may be divided by colour if permission of the CKC is obtained.

(h) **Veterans Class (Specialty Shows Only)** Dogs 7 years of age and over on the day of the show. This class may, at the discretion of the club, be divided by age into not more than three age divided classes. Dogs entered in these classes may be spayed or neutered.

### (j) Specials Only

(i) Dogs which have a recorded CKC registration, Event Registration Number (ERN) or Miscellaneous Certification Number (MCN) and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible. After awarding Best of Breed, Best of Opposite Sex and Best of Winners in each breed, the judge may choose a Select Dog and Select Bitch if there are dogs in the ring eligible for these awards. The Select Dog and Bitch must be awarded in the Specials Only class. The dog and bitch selected must be champions and cannot be the Best of Breed or Best of Opposite Sex Winners.

(ii) A dog entered in Specials Only shall be identified by gender in the judge's book and if incorrectly entered and substantiated by the show secretary or superintendent, shall be excused from the ring by the judge.

### 12.2.2 Miniature Dachshund – Foreign Born

If still under one year of age, a foreign-born Miniature Dachshund is eligible to enter the Specials Only class after completing the requirement for a CKC championship provided the application for registration is received by the CKC within 30 days of the dog reaching one year of age. Failure to do so will result in automatic cancellation of all points on record

1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.

5. Exhibitors are solely responsible for the conduct of their animals while they are on the Show Grounds. Exhibitors are responsible for their equipment and possessions. Equipment will **not** be left on the show grounds overnight.
6. Dogs must be ready for judging. The club will not be responsible for and not obligated to provide any service for notifying owners or agent of breed or class judging. **NO RING WILL BE HELD UP WAITING FOR EXHIBITORS OR HANDLERS.**

8.9.3 – When one or more all-breed and/or Specialty shows are held on the same day, in the same venue, the request for moving class dogs to specials MUST be made a minimum of one hour prior to the scheduled start of the all breed or Specialty show.

12.3.1 – A Puppy awarded Best Puppy in Group is NOT required to stay for Best Puppy in Show

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded Winners shall be as follows:

A dog awarded WINNERS at a Championship show shall be credited with a number of championship points ranging from 0 to 5 the number of championship points shall be as follows:

In addition to championship points allocated at the breed level, a dog awarded WINNERS which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the group level.

A Dog may not be credited with more than 5 points in a single show.

### Points for Best in Show

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall **NOT** be included in the calculation for championship points effective January 1, 2012. Absentees are not to be included. In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN).
